5. National Crime Victims' Week – Resolution

The Superintendent read the following resolution:

WHEREAS, the Fund comprises fines and penalties levied on offenders and affirms the principle that those who commit crimes should be held accountable for their actions; and

WHEREAS, the Crime Victims Fund supports more than 4,400 state and local victim assistance programs, including rape crisis centers, domestic violence shelters, child abuse prosecution, victim assistants in law enforcement and prosecutor offices, and other direct service providers that help millions of victims every year; and

WHEREAS, the Escambia County School District is joining forces with victim service programs, criminal justice officials, and concerned citizens throughout Florida and America to observe the 25th anniversary of the Victims of Crime Act during National Crime Victims' Rights Week and celebrate "Twenty-five Years of Rebuilding Lives".

6. Youth Success Week – Resolution

The Superintendent read the following resolution:

WHEREAS, the Florida Department of Juvenile Justice supports a balanced approach to juvenile justice and is committed to protecting Florida's citizens; responding to victims of juvenile crime, preventing juvenile crime, meeting the treatment needs of juvenile offenders, diverting youth from a life of crime and returning youth to their communities as productive citizens; and

WHEREAS, the Department's targeted services, coupled with appropriate consequences, accountability and treatment for juveniles who commit serious crimes, have resulted in significant reductions in juvenile crime; and

WHEREAS, law enforcement, the court system, program providers, local boards and councils, schools, volunteers, and other juvenile justice partners – including parents – work tirelessly with young offenders, leading to declining juvenile crime rates; and

WHEREAS, juvenile justice programs have assisted juvenile offenders in remaining crime free, leading to fewer crimes and more saved lives; and

WHEREAS, we are all a part of the school system and community believing that working together, we can make a difference in our students' lives; and

WHEREAS, the Escambia County School District is commemorating its fifteenth year of collaborating with the Department of Juvenile Justice service to the citizens of Florida, the District has adopted and proclaimed "Part of the Community, Part of the Solution" to be the theme for Youth Success Week 2009;

NOW, THEREFORE, BE IT RESOLVED, that the School Board of Escambia County does hereby recognize the week of April 19-25, 2009, as

and calls upon families, schools, religious and civic organizations, businesses and communities to become our partners in preventing juvenile crime.

7. Recognition of Quientella Bonner, 2009 Southeastern Conference (SEC) Greats Program

The Superintendent announced that Ms. Quientella Bonner, a physical education teacher at Scenic Heights Elementary and former outstanding basketball player at the University of Florida, was recently honored as part of the 2009 SEC Greats Program. The 2009 Class of the SEC Greats Program was honored at the SEC Women's Basketball Tournament held March 5-8, 2009, at Alltel Arena in North Little Rock, Arkansas and featured former outstanding student-athletes from all 12 Southeastern Conference member institutions. Each honoree was introduced during the half-time of their teams first game of the tournament. All 12 individuals were also introduced as a group between games of the second session on Friday, March 6th. The Greats then participated in an autograph session on the concourse before game eight. Ms. Bonner, who played in 102 games during her collegiate tenure, is one of the original "Gator Greats." Her name remains prominent in Florida's all-time basketball record book and is still among the program's career leader for several statistical categories, including number 1 for rebounds (1,321), number 2 for blocked shots (230), number 2 for scoring average (17.6 points per game), number 2 for rebound average (12.9 rebounds per game), and number 5 for scoring (1,789 points). Ms. Bonner's 31 rebounds against Georgia Southern on January 8, 1977 remains the all-time SEC single-game record, while her 45-point effort versus the University of Tennessee in Chattanooga on January 22, 1977 is still Florida's all-time single-game

record. Ms. Bonner, who is 5-foot-11-inch and was the forward/center, was inducted into the University of Florida's Athletics Hall of Fame in 1998.

8. School Library Media Month – Resolution

Mrs. Husbands commented that it was "ironic that on a day when we are honoring media centers and our media specialists, we have received word that because of budget cuts, that probably today, at least four high schools have cut media specialists in their schools – not because they don't believe in the media program, but because of a financial condition that we find ourselves in, it's become a necessity."

9. Dr. Paula Gleason Award

Each year the Dr. Paula Gleason Award is presented to the media specialist of the year whose library program exemplifies services to students and staff as evidenced by Dr. Gleason's vast and significant contributions to the professional development of library media services in Escambia County.

The Superintendent announced that the recipient of the 2009 Dr. Paula Gleason Award was Ms. Dawn Gibbs, Media Specialist at Bellview Middle School.

WHEREAS, Mr. Haynes was the captain of the 1940 football team and the only former player to return and serve as head football coach; and

WHEREAS, Mr. Haynes was head football coach at Pensacola High School during the integration of the Escambia County School System, and because Mr. Haynes led by example that a man should be judged only by his work ethic and commitment to success and not by the color of his skin, there were never any serious problems; and

WHEREAS, This community and state are influenced daily by doctors, lawyers, businessmen, and educators whose lives were molded under Mr. Haynes' tutelage.

NOW, THEREFORE, BE IT RESOLVED that the School Board of Escambia County, Florida, recognizes James W. Haynes for his selfless service and contributions to the Escambia County School District and to the Community and names the Athletic Complex at Pensacola High School in his honor.

Ms. Boehme asked the Board and the Superintendent to join her in recognizing both the District and Escambia Education Association (EEA) bargaining teams for their time and effort in negotiating the Master Contract. Motion was approved 4 to 1, with Mr. Bergosh voting "No."
