Mrs. Laura Shaud, Director of Budgeting, reviewed various forms of information that had been provided to the Board with regard to the 2008-09 budget. Throughout the meeting, staff responded to general questions posed by individual Board Members with regard to various aspects of the budget.

Mrs. Hightower commented, that should the financial situation for 2008-09 improve and the District have more funds than anticipated, she would like for the Board and the Superintendent to discuss their priorities in terms of restoring items that were previously eliminated from the budget. She cited the following positions as her personal restoration priorities: 1) Art, Music or Physical Education elementary teaching units; and 2) support staff at the high school level. Her desire was to make certain that classroom positions were restored prior to the restoration of any administrative positions.

Use of Molino Park Elementary School as Pet-Friendly Hurricane Shelter

She was not certain that Molino Park Elementary School, or any school facility for that matter, would be an appropriate setting for a pet-friendly shelter. The Superintendent assured Board Members that the School District was not obligated to any decision made by the County Commission with regard to this issue. It was noted that the Superintendent, his staff, and Board Members would ultimately decide whether or not usage of the Molino Park Elementary facility, or any school facility, was appropriate for a pet-friendly shelter.
