# I. CALL TO ORDER

Mrs. Moultrie called the Regular Meeting to order at 5:30 p.m. She welcomed those in attendance to the regular monthly meeting of the Escambia County School Board and thanked them for their interest in public education, and in particular, the education of students in Escambia County, Florida.

Mr. Slayton called for a moment of silence to reflect on the 2017 New Year. Mr. Slayton then led the Pledge of Allegiance to the American Flag.

b. Adoption of Agenda

The Superintendent noted the changes made to the agenda since initial publication. Mrs. Moultrie advised that Florida Statutes and School Board Rule required that changes made to an agenda after publication be based on a finding of good cause determined by the person designated to preside over the meeting and stated in the record. Mrs. Moultrie said she, as School Board Chair, had determined that the Superintendent's recommended changes to the January 17, 2017 Regular Meeting agenda were for good cause. Motion by Mr. Adams, seconded by Mrs. Hightower, to adopt the agenda (*as amended*), carried unanimously.

2. Stellar Employee of the Month

# PBIS Model School Awards

The Superintendent made the following announcement: It is my honor to present to you the 2015-2016 PBIS: MTSS model school recipients. This year we have nine schools that have met the requirements to become a PBIS model school. It should be noted that we have more model school award recipients this year than in any other year in the past. PBIS is the application of evidence-based strategies and systems to assist schools to increase academic performance, increase safety, decrease problem behavior, and establish positive school cultures. This process is a team-based approach that relies on a strong collaboration between families and professionals from a variety of disciplines regardless of the level implemented. We would like to begin by recognizing our four bronze level model schools. In order to receive bronze status, schools must demonstrate an overall

effectiveness of tier one behavioral data and use this data to develop a plan of action that ensures equitable behavioral outcomes for all students. Mr. Jeremy Tompkins, PBIS district coordinator, will announce our bronze level schools:

Pleasant Grove Elementary School – Principal Pam Mullen, Assistant Principal Julie Pearson, Alice Downs, and Amber Gunnels

West Pensacola Elementary School – Principal Sabrina Cunningham, Assistant Principal Tim Rose, and PBS Coach Kelley Morris

Next we would like to recognize our four gold-level schools. In order to receive gold status, schools must demonstrate overall effectiveness in all three tiers of the systems of support. As with the bronze level, to receive gold status the team members had to develop a plan of action to reduce disproportionality and implement the plan with fidelity. WHEREAS, military volunteers serve as Youth Motivator Mentors and are matched one-on-one with students and spend one hour a week at the schools; and



As Mrs. Hightower thought it would be helpful for the public, Mr. Shawn Dennis, Assistant Superintendent for Operations, took a moment to explain the reason for the rate differences in each of these contracts. Prior to the negotiation of these contracts, all schools consuming natural gas were paying a standard fixed rate of \$4.95/MMBTU; now schools would pay a rate of \$2.95/MMBTU to \$4.95/MMBTU, based on consumption volume and resulting in a net savings in overall natural gas costs. Mrs. Hightower expressed appreciation to School District staff for being good fiscal agents of taxpayer money and applauded their efforts in reducing energy costs. Motion carried unanimously.
