Placement to be at the discretion of the Superintendent and to be available as an alternative during the full expulsion time frame.

Recommend that, consistent with the decision of the due process committee, student number 07-179-862 be expelled from all public schools of Escambia County for the remainder of the 2006-2007 school year and all of the 2007-2008 school year with the option to enroll, if qualified and if space is available, in an alternative educational program exclusive of regular

- school placement. Placement to be at the discretion of the Superintendent and to be available as an alternative during the full expulsion time frame.
28.
